Co-op Engine reimbursements paperwork has been submitted for personnel and trucks and DNR will be replacing their personnel for the remainder of the contract period. ROCKY BUTTE REPORT: Captain Sal Rodriguez reported firefighters responded to 1 fire call. Firefighters were on the same training schedule with Brewster firefighters.

EMS DIRECTOR REPORT: Tonya reported the District did well with our Financial and Federal Audit and the report was available for review and also had been emailed to each Commissioner.

CDBG update was given and is currently in the closeout reports phase. A final public hearing is scheduled at the Okanogan County.
